

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.h2bsuite.com/> and H2 Buy Suite LLC and governs data collection and usage. The H2B Suite website is an Affiliated Business site. By using the H2B Suite website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, H2B Suite may collect personally identifiable information, such as your:

- First and Last Name

- Mailing Address

- E-mail Address

- Phone Number

If you purchase H2B Suite's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
